

Unlimited Driving Range Membership Terms and Conditions

Thank you for supporting The First Tee of NWA by joining our unlimited driving range membership. Your funds will help us support NWA kids through our programs and outreach activities in the community. We teach kids 5-18 life skills and 9 core values through the wonderful game of golf.

One of the core values we teach over 10,000 kids per year is respect. We teach them how to respect themselves, others' property, rules and policies. We would appreciate you for modeling this behavior for our youth by respecting our rules and policies set forth in our unlimited driving range membership.

We are offering this program for individuals and families. Families are defined by a limit of 5 people. If a family consists of 6 or more, we will require an additional fee for individuals beyond 5.

MONTHLY MEMBERSHIP:

I agree that the membership is for the person or family member that purchased the membership. No other person can use the membership. If a membership is used other than by who purchased it, The First Tee of NWA has the right to cancel the membership. If you choose a Monthly Membership, you agree that as a condition of your continued membership at First Tee of NWA you authorize First Tee of NWA to charge your Payment Card the Monthly Membership fee on each monthly periodic anniversary date of your membership, until your Monthly Membership is canceled. I agree to pay the one time, non-refundable initiation fee.

FEES RELATING TO YOUR PAYMENT CARD:

You are solely responsible for any and all fees charged to your Payment Card by the issuer, bank or financial institution including, but not limited to, membership, overdraft, insufficient funds and over the credit limit fees.

EXPIRATION DATE AND REFUSAL OF CHARGES TO YOUR PAYMENT CARD:

If your Payment Card reaches its original expiration date, your failure to cancel your Monthly Membership constitutes authorization for First Tee of NWA to continue billing that Payment Card. If your Payment Card for any reason will not accept charges for any periodic membership fee, you have a period of 10 days from the date that your Payment Card was declined to make your Payment Card information valid by either rectifying the issue with the Payment Card issuer or providing new Payment Card information. If First Tee of NWA is able to charge your Payment Card (existing or new, if you have provided new Payment Card information,) during the 10-day period and any past due First Tee of NWA membership fees are paid, then Monthly Membership benefits will continue uninterrupted and this Payment Card will be used to charge the applicable periodic membership fee for each consecutive renewal period until your Monthly Membership is cancelled (your original anniversary date will still apply) and will be your Payment Card for all purposes. If First Tee of NWA is unable to charge your Payment Card (existing or new, if you have provided new Payment Card information,) within the 10-day period, then your Monthly Membership will be indefinitely suspended beginning on the 11th day from the date your Payment Card was initially declined.

ANNUAL PAYMENT:

Members have the option of paying for the entire 12-months up front, rather than monthly billing. Payment made for this Annual Membership is non-refundable.

SUSPENSION/TERMINATION/CANCELATION:

I have the ability to cancel my membership at any time by providing a written or in person notice no less than 10 days prior to my withdrawal date. Canceling less than 10 days before my next withdrawal date will result in my card being charged the full amount of my monthly fee. If I cancel my membership, it is still active until the date of my next withdrawal. If the Monthly Membership is canceled by the individual, I understand that I must pay the initiation fee to resume the membership in the future. First Tee of NWA may suspend or terminate your membership at any time for any breach of this Agreement or for any other reason by giving you written or oral notice of such termination, with or without cause. If First Tee of NWA terminates your membership, you must immediately surrender your membership, and you will not receive a refund of any amounts paid under any type of membership.

INDOOR FACILITY:

If there are people waiting to hit balls in the indoor facility, we will invoke a time limit so we can allow everyone the same opportunity to hit balls. First Tee classes will take priority of the public use.

HOURS OF OPERATION:

From time to time, First Tee of NWA may make reasonable changes to the days and hours that our facility is open for business. You understand that First Tee of NWA will be busier at some times than others on different days of the week.

TEMPORARY CLOSURE:

First Tee of NWA may temporarily close the facility in its sole discretion for any reason including, without limitation, in the case of inclement weather. Members and guests are immediately required to comply with announcements and staff instructions regarding weather-related stoppages.

I HAVE READ, UNDERSTAND, AND AGREE TO ALL OF THE INFORMATION UNDER THE TERMS, CONDITIONS AND POLICIES OF THIS MEMBERSHIP AGREEMENT. IN ADDITION, I UNDERSTAND AND AGREE THAT THE ASSUMPTION OF RISK, WAIVER AND RELEASE OF ALL CLAIMS PROVISIONS SET FORTH IN THE TERMS AND CONDITIONS OF THIS AGREEMENT ARE IN EFFECT THROUGHOUT MY MEMBERSHIP WITH FIRST TEE OF NWA. THIS AGREEMENT IS THE ENTIRE AGREEMENT, AND NO VERBAL OR OTHER AGREEMENTS HAVE BEEN MADE TO ALTER THE TERMS OF THIS AGREEMENT.
